

Although a lot has been obtained through 12 years since the RTI Act was introduced, more strategic and sustainable efforts will be required. 			The 1 <sup>st</sup> strategic plan on RTI Act 2015-2021 is coming to an end, a new strategic plan 2022-2030 needs to be made for implementing RTI Act 2009 and pledges made internationally to fulfill the SDG targets assigned in goal 16 and other national Plan / policies of the Government of Bangladesh.			
			Towards that end a strategic plan 2022-2030 should provide necessary impetus for institutional arrangements to address both the constraints to the demand for information and the supply of information for improving the transparency, accountability and good governance in Bangladesh.
